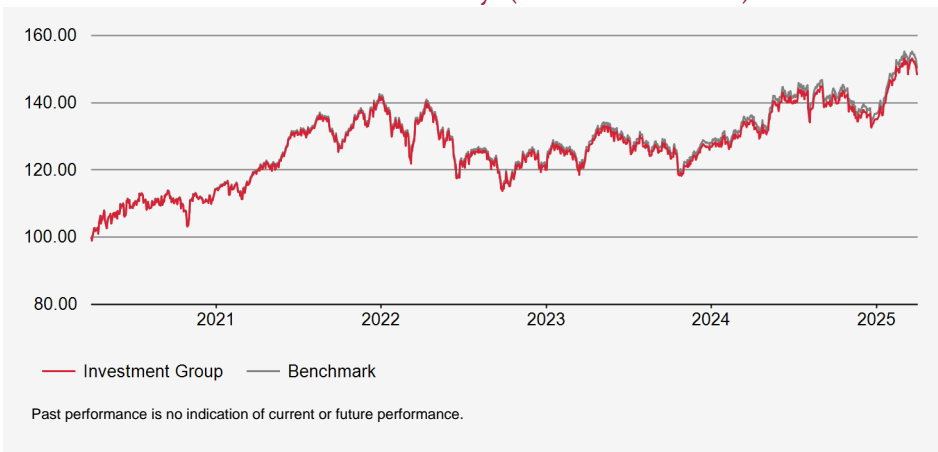

Investment Strategy

The investment group is managed using an indexed approach and is characterised by a broad diversification and a low tracking error. Implementation via investment in Swiss Life Index Funds (CH) Equity Switzerland Large Cap; contractual investment fund under Swiss law of the type "Other funds for traditional investments". Evolution in reference currency (base value 100)



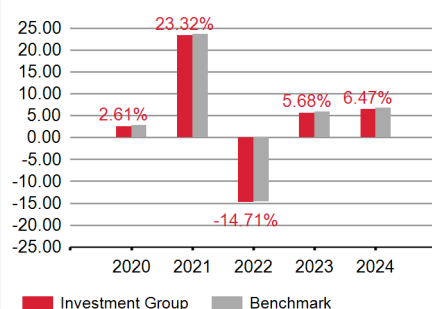
